MEMORANDUM OF UNDERSTANDING By and Between KITSAP COUNTY AND

WASHINGTON STATE COUNCIL OF COUNTY AND CITY EMPLOYEES, LOCAL 1308-S, AFSCME, AFL-CIO (COURTHOUSE SUPERVISORY EMPLOYEES)

RE: Temporary Out-of-Class non-union work to be performed by union members

The parties, Kitsap County (County) and Washington State Council of County and City Employees, Local 1308-S, AFSCME, AFL-CIO Courthouse Supervisory Employees (Union), having bargained in good faith over the terms of the current Collective Bargaining Agreement, KC-328-13 (hereinafter CBA), mutually agree as follows:

WHEREAS, a vacancy unexpectedly occurred in a Maintenance & Operations (M&O) Manager position in the Facilities Division of the Department of Information Services and Facilities:

WHEREAS, in the interests of consistency and to provide existing employees additional leadership experience, the County and Union agree that the vacancy should be temporarily filled by an M&O Crew Supervisor in the Facilities Division;

WHEREAS, the Facilities M&O Crew Supervisor is a Union, non-exempt position governed by the terms of the current CBA;

WHEREAS, the Facilities M&O Manager position is a non-Union, exempt position governed by the terms of the Kitsap County Personnel Manual; and

NOW, THEREFORE, the parties agree as follows:

- Any Union member temporarily assigned to work Out-of-Class in the Facilities M&O Manager position during the life of this Memorandum will continue to receive all benefits of the CBA, except as expressly provided in this Memorandum.
- 2. In accordance with the exempt status of the M&O Manager position, any Union member temporarily assigned to work Out-of-Class in the Facilities M&O Manager position shall not be eligible for the following benefits under the CBA:
 - a. Standby pay as outlined in Article II, Section I of the CBA; **provided**, however, the Union member will be eligible for standby pay as provided in Chapter 7, Section C of the Kitsap County Personnel Manual.
 - b. Call-back compensation as outlined in Article II, Section J of the CBA

- c. Overtime compensation as outlined in Article II, Section G of the CBA
- d. Any other benefits provided within the CBA that are dependent upon the employee being in a non-exempt status.
- 3. Any Union member temporarily assigned to work Out-of-Class in the Facilities M&O Manager position will be permitted to use compensatory time off accumulated prior to the Out-of-Class assignment. In accordance with Article II, Section G of the CBA, all accrued compensatory time off not taken prior to ninety (90) days after the effective date of this Memorandum shall be paid to the employee. Any compensatory time off used or paid out shall be paid out at the hourly rate at which it was earned.
- 4. Any discipline, scope of authority, or other working condition issues relating to or as a consequence of the supervisory responsibilities of a Union member temporarily assigned to work Out-of-Class in the Facilities M&O Manager position shall be governed by the Kitsap County Personnel Manual.
- 5. The temporary assignment of a Union member to perform Out-of-Class duties as the Facilities M&O Manager shall not extend the scope of Union work to include duties ordinarily performed by the Facilities M&O Manager.
- 6. Except as expressly provided in this Memorandum of Understanding, all other terms and conditions of the parties' original Contract, and subsequent amendments, addenda or modifications thereto, remain in full force and effect.
- 7. Except as expressly provided herein, this Memorandum of Understanding shall be effective September 21, 2017 through December 31, 2017, unless extended by mutual agreement of the parties.
