 - 1. Statement to the Bremerton City Council was released regarding the City Council's decision to remove protective language for our unhoused neighbors from a city ordinance. With the removal of the protective language, law enforcement is now able to clear out encampments *even if shelter beds are unavailable*. The letter was sent out to relevant and posted on the website for review.
 - ii. Events Debrief of Social Justice Gathering
