Summary:

The County's Budget Policies call for amendments to the budget to be made quarterly during the calendar year. This resolution, representing the budget amendment for the second quarter of 2024, increases spending authority in the general fund by \$128,566. All expenditure increases are supported by cash balances or increased revenues.
