Scope of Work.

Contractor's plan for training Attachment Biobehavioral Coaching, parent coaches will be supplied by a sub-contract through Kitsap Mental Health Services (KMHS), eliminating Flying Bagel Services (FBS).

- 1. Instead of training two (2) Spanish-speaking coaches, one with (FBS) and one with (KMHS), contractor will train three (3) coaches with KMHS, one (1) of whom is Spanish-speaking.
- Change will increase training costs. FBS will reduce indirect for the first two quarters to accommodate the increase and stay within budget.

Compensation.

No Compensation change in the grantee's award. Budgetary line items will change in value.
