This Contract between the State of Washington Department of Social and Health Services (DSHS) and the Contractor is hereby amended as follows:

A. The total maximum consideration is increased by \$9,743 for a new total maximum consideration of \$414,290.

B. Special Terms and Conditions, Section #3 Consideration, Statement of Work is revised to read:

Total consideration payable to the AAA for satisfactory performance of the work under this Agreement has been increased by \$9,743, for a new total maximum consideration of \$414,290.

The annual maximum consideration for milestones is \$223,920. The projected annual maximum consideration for unit rate per case payments has been increased by \$9,743 for a new maximum consideration for unit rate of \$190,361.

The allocation (1/1/24-12/31/2024) has a maximum consideration of \$414,290.

AAAs may adjust pricing costs between milestones of Exhibit B and within the maximum consideration of this Agreement with prior written approval by ALTSA. These changes may be made without amending this Agreement.

All other terms and conditions of this Contract remain in full force and effect.
