This Contract between the State of Washington Department of Social and Health Services (DSHS) and the Contractor is hereby amended as follows:

- **A. Exhibit B-2, Budget**, is revised and replaced by Exhibit B-3, Budget, approved line-item Budget, which is attached hereto and incorporated herein.
- **B.** The maximum consideration is increased by \$222,200: [\$1,900 of state Senior Farmers Market Nutrition funding (\$1,400 for Administration, \$500 for Nutrition Education), \$215,000 for Case Management/Nursing Services—Core Services, and \$5,300 for State Family Caregiver Support Program] for a new maximum consideration of \$4,595,388.

All other terms and conditions of this Contract remain in full force and effect.
