For funding provided under this Agreement, the de minimis indirect rate is as follows: for PY24/FY25 funds allocations, PY24 funds de minimis indirect rate is ten percent (10%) for the lifetime of the funds, while the FY25 funds de minimis indirect rate is fifteen percent (15%) for the lifetime of the funds.</p>
