

**CONTRACT NO. KC-475-23-A
CONTRACT AMENDMENT**

This Contract Amendment ("Amendment") is between Kitsap County, a Washington state political subdivision, having its principal offices at 614 Division Street, Port Orchard, Washington 98366 ("County") and The Salvation Army, a California non-profit corporation having its principal offices at 30840 Hawthorne Blvd., Building D, Rancho Palos Verdes, CA 90275 ("Contractor").

In consideration of the mutual benefits and covenants contained herein, the parties agree that their Contract, numbered as Kitsap County Contract No. KC-475-23 ("Contract") executed on November 27, 2024, is amended as follows:

1. SECTION 1. TERM, shall be amended to terminate on September 30, 2024.
2. ATTACHMENT B, Scope of Work, shall be amended as follows:
 - a. Section B – Project Summary time frame is extended to September 30, 2024.
 - b. Section F – Project Schedule is extended to September 30, 2024.
 - c. Section I – Project Budget is increased to \$1,539,141.
3. ATTACHMENT C, Cost Certification Section 1., shall be amended to October 15, 2023 through September 30, 2024.
4. FACE SHEET, shall be amended as follows:
 - a. Section 5 – Subaward Period of Performance is amended to 10/15/23-09/30/24.
 - b. Section 7 is increased to \$1,539,141.
 - c. Section 8 is increased to \$1,539,141.
 - d. Section 9 is increased to \$1,539,141.
5. Except as expressly provided in this Contract Amendment, all other terms and conditions of the original Contract, and any subsequent amendment, addenda, or modifications thereto, remain in full force and effect.
