I. INTRODUCTION

The Petitioner, through its authorized representative, requests that this Court set a Show Cause Hearing in the above captioned matter and order the: Student and/or Parent(s) to personally appear at the hearing.

Pursuant to RCW 28A.225.090 and RCW 7.21.030 this Court may enter an Order of Contempt against a party if the Court should find that the party has failed to comply with an order of this Court.

MOTION

The Student and/or Parent(s), having had notice of the court order, *willfully* refused to abide by the court order, has no lawful excuse for failing to obey the Court's order and has the *ability* to comply with the order and is in contempt of this Court.

The moving party requests that the Court issue an Order to Show Cause which directs the Student and/or Parent(s) to appear before this Court and show why an Order of Contempt should not issue.

II. FACTS

This Court entered an order to Compel School Attendance dated _____ which ordered the: Student to attend school with no unexcused absences, tardies, suspensions, expulsions, or behavioral referrals Parent(s) _____ to cause the student to attend school.
