In the PROS document Howe Farm Park is listed as a Legacy Park and now Community Park, containing about 81 acres. The use table lists about 14 visitors per day for this Park. Howe Farm Dog Park became a separate entity in early 2008 when an area of about 13 acres, 7.5 ac in forest and 5.5 ac in grassland, was fenced off from the rest of Howe Farm. Howe Farm Dog Park is maintained by myself and other volunteers who work on selected days during the summer. Funding for materials needed to maintain the Park (trail gravel, fence posts, and some tools) is provided by Kitsap Dog Park is. The Parks Dept. provides help with removing fallen and hazardous trees and with mowing of the grassland in summer. The Parks Dept is still responsible for the Park and no work, outside of everyday maintenance, can be done without there notification and approval. Two, week-Iong use studies were done in the winter of 2018-19 and the summer of 2019. Average daily people visits were 186 and average daily dog visits were 215 animals. There are currently three dog Parks in the County. Only Bandix Dog Park is listed by name. Howe Farm Dog Park and Silverdale Dog Park are not named but the area Park of which they are associated, is. On page 94 of the PROS, a section on Canines is dedicated to the importance of dogs to many County residents but the Dog Parks are not mentioned specifically. I mention this because the County is under counting the number of users of their Parks since Howe Farm has only 14 visitors per day where as Howe Farm Dog Park has average daily people visits of 186.

			I make mention of this because most people can't deduct or identity this when reading thru the information or hearing the results from you in meetings. I think it is important that those of you representing the PROS plan acknowledge this gap in survey respondents – essentially stating that the results are somewhat biased towards age groups that prefer passive recreation vs. other activities (active recreation like using sports fields and indoor facilities). This is exactly what was highlighted and acknowledged from our BERK report in the feasibility study we forwarded to you. To address this needs gap, the PROS plan should reference the survey work done by Rotary, the YMCA, and other Kitsap Youth Organizations recently conducted and include these results in the PROS plan appendices. This is why we felt it was prudent and important to put in a lot of time (and pay a lot of money) to get other information to compliment your PROS Plan Survey.
