Barriers to Use:



- 1. Access and Safety:
- Concerns about park accessibility and safety.
- Suggestions for better signage and maps to navigate parks.
- Request for improved trail maintenance and upkeep.
- Concerns about safety due to homeless encampments.
- Desire for more security and enforcement in parks.
- Need for security measures to ensure safe park experiences.

- 2. Trail Development and Connectivity:
- Desire for more trail development and connectivity.
- Update trails and pathways for accessibility.
- Need for better-connected trail networks.
- Suggestions for adding trailheads and fixing bridges.

3. Recreation Facilities and Programs:

• Request for more recreation facilities like pickleball courts, BMX tracks, and pump tracks.

• Need for additional indoor basketball courts, turf fields, and swimming pools.

- Support for more youth and adult sports facilities & programs.
- Requests for more soccer fields and turf fields.
- Calls for equitable distribution of field access.

- 4. Nature Preservation and Conservation / Resiliency:
- Emphasis on preserving natural habitats as critical public infrastructure.
- Concerns about the impact of development on wildlife.
- Support for conserving open spaces and forests.
- Emphasis on environmental preservation and carbon sequestration.
- Concerns about impacts of sprawl and development.
- Calls for setting aside open space and conserving forests.




Conservation – Open Space

- Protection for tree buffers and animal through-ways near the Anderson Landing Preserve and Silverdale Wetlands
- Requests for conservation and restoration, specifically at the Illahee Preserve, Port Gamble Forest Heritage Park, and Buck Lake
- Suggestion for master gardeners native plant parks or p-patch parks in the Port Orchard/Fernwood/Bethel area




Conservation – Additional Comments

- Balancing wildlife habitat protection with human recreation.





- Concerns for unsafe biking routes, and suggestions for dedicated paths and shared use trails






Access & Safety – Improvements

- Many requests for improved parking facilities
- Safer bicycle routes
- Reduced vehicle speeds
- Removal of vegetation to improve sightlines and visibility for bicyclists and pedestrians.
- Specifically at the Port Gamble Forest Heritage Park, there were suggestions to include no-bike areas to increase pedestrian safety.




New Facilities - Rec

- Disc golf was requested across the county, with the densest spots near the Kitsap Fairgrounds & Events Center and Square Lake Park.
- Pickleball courts were requested most in the central part of the county, with the densest spots near Bill Blomquist Rotary Park and Old Mill Park.
- Soccer fields were mostly requested near Veterans Memorial Park, Kingston Nike Site, and Port Gamble Forest Heritage Park.
- Off-leash dog parks were primarily requested near Bremerton, Kingston, and the Port Gamble Forest Heritage Park.
