

## Questions & Answers – March 07, 2025 Attachment to ADDENDUM # 1

The County has received Questions from prospective bidders. Below are the County's corresponding answers:

- Question: Is there access to the beach through the boat ramp?
- **Answer:** The county does not have any access rights to the boat ramp through Tribal property. Access to the outfall and county right-of-way at toe of bluff is only available via the top of bluff or via navigable waters.
- Question: Is the bluff wall covered under the same bid item as the anchor/pipe?
- **Answer:** Yes, the bluff wall, or Trench Bluff Backfill (Detail 3, sheet 11), is covered under Schedule A, bid item A25, for "Outfall Pipe Anchor."
- **Question:** Will the County be taking care of the Biological Survey during the work window?
- **Answer:** The County will be responsible for coordinating the biological survey (for Surf Smelt Spawning).
- Question: What is the current water elevation?
- **Answer:** Based on NOAA Tide Predictions' historical data, the tidal elevation was approximately 8.5 ft (MLLW) at the start of the pre-bid meeting (Port Madison Station 9445753). See Figure 1 below.







**Question:** Will there be any road closures permitted?

- **Answer:** WB NE Parkway may be closed to traffic to facilitate the work, as shown in the Traffic control plans included in the Contract Provisions. Suquamish Ave may be closed for a maximum duration of 12 hours and not exceeding five (5) closures to facilitate the work. The contractor must submit a road closure request, traffic control plan, and detour plan for review and approval by the county.
- Question: Is there a County ROW permit included?
- **Answer:** The contractor is responsible for submitting a ROW permit application for the work, but it will be a no-fee permit.
- **Question:** What are the limits of the trench bluff restoration? There doesn't appear to be item for it, and we're trying to determine quantities.
- **Answer:** The limits of the trench bluff restoration detail coincide with the contractor's trench excavation limits, if open trenching through the bluff.
- Question: Is the 24-hour leak test of the main treatment vault necessary?
- Answer: The leak test is not required.
- Question: Can the media and mulch be placed prior to putting the lids on?
- **Answer:** The contractor must follow the manufacturer's recommendations for media placement.

# **Question:** Can the County provide a copy of the sign-in sheet from the pre-bid meeting?

**Answer:** Yes, the sign in sheet is attached below.
