## Notice Regarding Storage Facilities for On-Site Auctions

The following list identifies storage facilities within Kitsap County that have self-certified their willingness to permit the Kitsap County Sheriff's Office (KCSO) to conduct on-site public auctions of personal property.

1. No Endorsement, Disclaimer of Liability: KCSO does not endorse, recommend, or vet any specific storage facility. KCSO has not evaluated these facilities for security, pricing, accessibility, or business practices. Furthermore, KCSO has no knowledge of, and makes no representations regarding, the licensing, bonding, or insurance coverage of any facility on this list. The inclusion of a facility is based solely on their expressed willingness to host on-site Sheriff's sales. The selection of a facility is at the sole discretion and risk of the Plaintiff and/or the Plaintiff's Attorney, who are encouraged to perform their own due diligence. KCSO assumes no liability for the choice of facility or any outcomes resulting from its use.
2. Informational Purposes Only: This list is provided as a courtesy to identify locations where KCSO is logistically able to perform its statutory duties. KCSO currently requires auctions to be conducted on-site; facilities that only permit online auctions are not compatible with current KCSO auction procedures.
3. Third-Party Contracts: Any agreement for storage is a private contract between the Plaintiff and the storage facility. KCSO is not a party to these agreements and is not responsible for any fees, damages, or disputes arising from the storage of property.
4. Reservation of Rights: KCSO reserves the right to remove any facility from this informational list at any time, without notice, for any reason, including but not limited to: failure to cooperate with KCSO auction procedures or credible reports of unethical business practices. Inclusion on this list is a courtesy and does not create a contract or a right to remain listed.
5. Open Participation: This list is non-exclusive. Any storage facility in Kitsap County that wishes to permit on-site KCSO auctions may request to be added to this informational list by contacting the KCSO Civil Division.
