Dear County Treasurer,

We highly value our partnership with the counties to administer forest taxes. In 2018, DOR launched a new tax and licensing system. Among other functions, Revenue uses this system to help collect forest tax revenue on behalf of 35 counties and distribute each counties' share of the forest tax revenue back to them.

Due to a technical issue within that new system, DOR's costs for administering the taxes have not been deducted from your county quarterly distributions since November 2018. The counties' share of those administrative costs so far has been covered by forest tax revenue collected for the state. This issue has resulted in the counties receiving additional forest tax revenue over the past several years.

Under Washington state law DOR is required to collect those costs. It is now DOR's responsibility to work with you to recoup those administration costs. We are reaching out to each of the 35 affected counties to determine the following:

- A plan that works to lessen the impact of this issue while fully recouping the overdistributed amount.
- Giving options to pay now, reduce your August 2021 revenue distribution or make regular payments to the state.
- The ability to repay the over-distributed amount for up to three years with no interest.

DOR is in the process of configuring its tax and licensing system to ensure the county administrative costs are deducted before distribution in time for the August 2021 distributions.

Please contact me by July 30, 2021 to discuss your repayment option.
